All entries must be purchased at Gisburn Auction Marts Ltd sales between 3rd August 2017 and 25th November 2017 inclusive and sold at Gisburn Auction on 3rd March 2018. This competition is open to anyone aged 27 and under as at 2nd March 2018. Upon signing this form, you agree to have read, understood and abide by the rules of the competition overleaf.

RULES OF THE GISBURN AUCTION MARTS LTD - CATTLE OVERWINTERING COMPETITION 2018

1. The competition is open to all young people aged 27 and under as at 2nd March 2018.
2. The stock must be **purchased by the competitor in person** at any Thursday calf, stirk or Saturday store sale conducted at Gisburn Auction Marts Ltd between 3rd August 2017 and 25th November 2017 inclusive.
3. Participants must register their animals **on the day of purchase** with Ann Faraday or Rachel Capstick at the main auction office by completing an entry form and paying the **£10 non-refundable entry fee per animal**. The office will then record the purchase date, weights and prices of the animal(s).
4. Each competitor may enter a maximum of 2 cattle (cannot be shown in the same class) however, only the first animal will be eligible for finance by Gisburn Auction Marts Ltd. Any second animal to be purchased at the competitor's own expense and paid for in full within two weeks of the date of purchase.
5. Each entry must be **prepared and shown by the competitor**, therefore each competitor can only have one entry in each class.
6. The stock must be overwintered by the competitor or his/her employer and must be available for inspection on the farm at any time, by the organisers.
7. The stock must be presented for show on the evening of Friday 2nd March 2018 at Gisburn Auction (judging time to be confirmed) and offered for sale by the competitor at Gisburn Auction Marts Spring Show & Sale on Saturday 3rd March 2018.
8. **All animals must be halter-led to compete in the show classes.**
Unhalted cattle will be included in the competition for daily live weight gain and gross margin but will *not* be eligible for show.
9. Judges will be appointed by Gisburn Auction Marts Ltd.
10. The competitor or competitors' guardian (if competitor is under 18 years old) is responsible for any loss or injury to the animal and are responsible for reimbursing Gisburn Auction Marts Ltd. the purchase price.
11. Cattle withdrawn from or not sold at the sale will forfeit all prize money and payment of the purchase price plus 5% will be required on the Spring Cattle Sale day 2018.
12. **Female cattle** must be 'clean' and warranted free of the bull. Cows, calved heifers or in-calf heifers will *not* be eligible for the competition.
13. In the case of cattle purchased using Mart finance, Gisburn Auction Marts Ltd will pay over to the competitor, the balance between the sale proceeds and the original purchase price minus the normal 3% Auction Mart commission plus VAT.
14. Any shortfall between the sale price and purchase price must be paid over to Gisburn Auction Marts Ltd by the competitor.
15. Gisburn Auction Marts Ltd Directors will be the sole arbiter of these or any amended rules.
